**Re: Your request for access to information under Part II of the *Access to Information and Protection of Privacy Act, 2015* [File #: EC/18/2017]**

On May 12, 2017, Executive Council received your request for access to the following records/information:

*“I am requesting a copy of all appointments made by the Premier, and the date of the appointment, the term of the appointment and any remuneration associated with the appointment from Sept 26, 2014 to Nov 30, 2015.”*

On May 29, 2017 you clarified you were seeking appointments made in accordance with the *Executive Council Act*. You also indicated you were not seeking the remuneration associated with these appointments.

I am pleased to inform you a decision has been made by the Deputy Clerk of Executive Council to provide access to the information requested. A request to the Commissioner must be made in writing within 15 business days of the date of this letter or within a longer period that may be allowed by the Commissioner.

You may also appeal directly to the Supreme Court Trial Division within 15 business days after you receive the decision of the public body, pursuant to section 52 of the *Act*.

Responsive records will be published following a 72 hour period after the response is sent electronically to you or five business days in the case where records are mailed to you. It is the goal to have the responsive records posted to the Completed Access to Information Requests website within one business day following the applicable period of time.
