On *May 14, 2019*, The Department of Tourism, Culture, Industry and Innovation received your request for access to the following records/information:

What is the amounts granted the Mistaken Point Cape Race Heritage Inc? What is the amount granted Battle Harbour Historic Trust? What is the amount granted the Grenfell Historical Society, St. Anthony?*
