Re: Your request for access to information under Part II of the *Access to Information and Protection of Privacy Act* (Our File #: EECD/045/2019)

On May 29, 2019, the Department of Education and Early Childhood Development received your request for access to the following records/information:

"Emails from the Minister or officials to MHA Tracey Perry regarding the replacement of Bay D'Espoir Academy. Time period Jan 18, 2017 to date of this request."

I am pleased to inform you that a decision has been made by the Deputy Minister for the Department of Education and Early Childhood Development to provide access to the requested information and the appropriate copy has been enclosed.

You may appeal this decision and ask the Information and Privacy Commissioner to review the decision to provide partial access to the requested information, as set out in section 42 of the Act. A request to the Commissioner must be made in writing within 15 business days of the date of this letter or within a longer period that may be allowed by the Commissioner. Your appeal should identify your concerns with the request and why you are submitting the appeal.

You may also appeal directly to the Supreme Court Trial Division within 15 business days after you receive the decision of the public body, pursuant to section 52 of the Act.

Please be advised that responsive records will be published following a 72 hour period after the response is sent electronically to you or five business days in the case where records are mailed to you. It is the goal to have the responsive records posted to the Completed Access to Information Requests website within one business day following the applicable period of time. Please note that requests for personal information will not be posted online.
