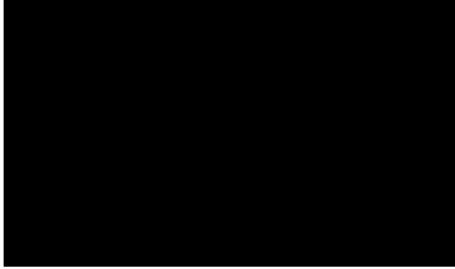

**Re: Your request for access to information under Part II of the *Access to Information and Protection of Privacy Act* (File # NR-193-2019)**

On September 23, 2019, the Department of Natural Resources received your request for access to the following records/information:

**For each of the years 2015, 2016, 2017 and 2018 please advise as to how many quarry permits and/or quarry leases were owned/operated by ALPHONSUS ST. GEORGE & SON LTD. For each permit/lease provide the Department of Natural Resources File number or Permit ID. For each permit/lease provide the volume removed and the royalties paid to the Department of Natural Resources**

I am pleased to inform you that a decision has been made by the Department of Natural Resources, confirmed by the Deputy Minister, to provide access to the requested records. The record is attached.

As set out in section 42 of the Act you may ask the Information and Privacy Commissioner to review the department's decision to provide access to the requested information. A request to the Commissioner must be made in writing within 15 business days of the date of this letter or within a longer period that may be allowed by the Commissioner. Your request should identify your concerns with the department's response and why you are requesting a review.

Pursuant to section 52 of the Act, you may also appeal directly to the Supreme Court Trial Division within 15 business days after receiving the department's decision.

Please be advised that responsive records will be published following a 72 hour period after the response is sent electronically to you or five business days in the case where records are mailed to you. It is the goal to have the responsive records posted to the Completed Access to Information Requests website within one business day following the applicable period of time. Please note that requests for personal information will not be posted online.
