Re: Your request for access to information under Part II of the Access to Information and Protection of Privacy Act [Our File #: HRS-42-2019]

This is to confirm that on August 9, 2019 the Human Resource Secretariat (HRS) received your access to information request via a transfer from Finance for the following information:

“This does not need to go through the formal ATIPP process, this can be considered a general information request, if need be. I request a list of all HRS employees that has been working in HRS since June 1, 2019 to present. By employees I include those that are full time, part time, on contract, work term students and/or summer students. I request only the first and last name of each employee along with their current position. I request, if possible, start and end dates for work term and summer students only.”

In an email correspondence on August 9, 2019, the request was modified to use June 1, 2019 to August 9, 2019 for all employees including work term and summer students as specific start and end dates would constitute employment history which is protected as personal information under Section 40(1) of ATIPPA, 2015.

I am pleased to inform you that a decision has been made by the Human Resource Secretariat to provide access to the requested information. In accordance with your request for a copy of the records, the appropriate copies have been enclosed.

The *Access to Information and Protection of Privacy Act* requires us to provide an advisory response within 10 days of receiving the request. As this request has been completed prior to day 10, this letter also serves as our Advisory Response.

Please be advised that you may ask the Information and Privacy Commissioner to review the processing of your access request, as set out in section 42 of the *Access to Information and Protection of Privacy Act* (the Act). A request to the Commissioner must be made in writing within 15 business days of the date of this letter or within a longer period that may be allowed by the Commissioner.
