Re: Your request for access to information under Part II of the *Access to Information and Protection of Privacy Act* [Our File #: SNL-024-2020]

On February 25, 2020, Service NL received your request for access to the following records/information:

"Requesting the following information from : Service NL - Boiler, Pressure Vessel and Compressed Gas Division 1. Total annual cost of all types of insurance paid out by the division from 2017-2019. 2. Total cost associated with each inspector from 2015-2019. This includes but is not limited to PPE, safety training courses, travel expenses, and NBBI (National Board of Boiler and Pressure Vessel Inspectors) certification. 3. - Annual pension and benefit contributions by the government to all inspectors from 2015 -2019."

I am pleased to inform you that a decision has been made by Service NL to provide access to the requested information in item 1 and 2. As per your email on March 4, 2020 item 3 of your request has been cancelled.

In accordance with your request for a copy of the records, the appropriate copies have been enclosed.

The *Access to Information and Protection of Privacy Act* requires us to provide an advisory response within 10 days of receiving the request. As this request has been completed prior to day 10, this letter also serves as our Advisory Response.

Please be advised that you may appeal this decision and ask the Information and Privacy Commissioner to review the decision to provide partial access to the requested information, as set out in section 42 of the Act (a copy of this section of the Act has been enclosed for your reference). A request to the Commissioner must be made in writing within 15 business days of the date of this letter or within a longer period that may be allowed by the Commissioner. Your appeal should identify your concerns with the request and why you are submitting the appeal.
