Re: Your request for access to information under Part II of the *Access to Information and Protection of Privacy Act* (File # NR-09-2017)

On February 1, 2018, the Department of Natural Resources received your request for access to the following records/information:

On your website is a list of the Prospector Assistance Grant Recipients and amounts given for 2015-16. I am seeking the list for 2016/17 with amounts.

I am pleased to inform you that a decision has been made by the Department of Natural Resources, confirmed by the Deputy Minister, to provide access to the requested information. The records are attached. We would like to note that this information will be posted on our website in due course. However, we are pleased to provide access to the requested information as part of this access to information request.

As set out in section 42 of the Act you may ask the Information and Privacy Commissioner to review the department's decision to provide access to the requested information. A request to the Commissioner must be made in writing within 15 business days of the date of this letter or within a longer period that may be allowed by the Commissioner. Your request should identify your concerns with the department's response and why you are requesting a review.

Pursuant to section 52 of the Act, you may also appeal directly to the Supreme Court Trial Division within 15 business days after receiving the department's decision.

Please be advised that responsive records will be published following a 72 hour period after the response is sent electronically to you or five business days in the case where records are mailed to you. It is the goal to have the responsive records posted to the Completed Access to Information Requests website within one business day following the applicable period of time. Please note that requests for personal information will not be posted online.
