Re: Your request for access to information under Part II of the *Access to Information and Protection of Privacy Act* TCII/8/2018

On March 7, 2018, the Department of Tourism, Industry, Culture, Industry and Innovation received your request for access to the following records:

"2017 and 2018 non-resident woodland caribou license allocations for all licensed outfitters and corporate lodges in the following caribou management areas: 61; 62; 64; 66; 67; 68; 69; 76; 78; and 79".



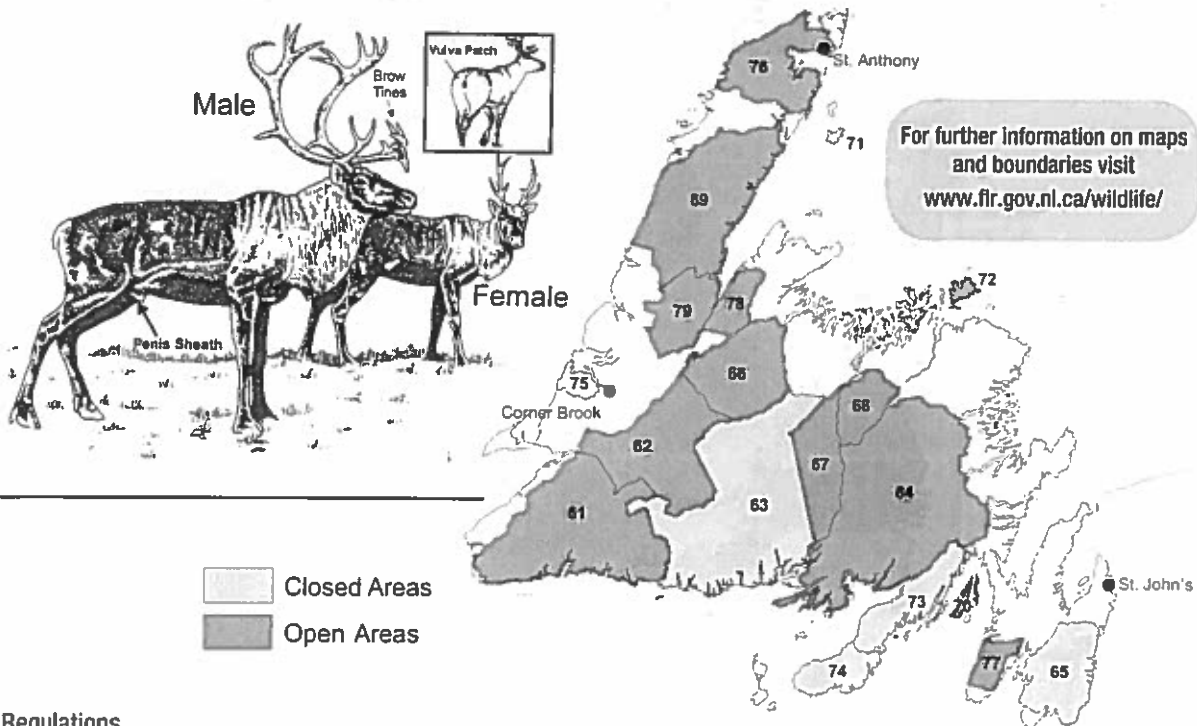

Regulations

- Bow hunting season begins August 26, 2017 in all CMA's, excluding 70 & 72.

ADVISORIES

- Hunters are advised against harvesting adult male caribou during the peak of the rut, generally the first three weeks of October, due to the possibility of the meat being unpalatable.
- It is unlawful for a person to allow harvested wild game that is suitable for food to be destroyed, wasted or spoiled.
