**Re: Your request for access to information under Part II of the *Access to Information and Protection of Privacy Act* [Our File #: FIN-65-2018]**

On June 25, 2018, the Department of Finance received your access to information request for the following:

“What is the total net income per district? What is the net income most popular in that district? Ex: minimum wage or over \$100,000 What is the employed population of each district? How many employed in each district are public Employees? How many are self employed? How many are employed by a non-government job? How many are on social assistance per district? How many are old age pensioners per district? How many unemployed with zero income supported by spouse or otherwise? If this isn't the right department for this information, please forward to the correct department.”

Please be advised that you may ask the Information and Privacy Commissioner to review the processing of your access request, as set out in section 42 of the Access to Information and Protection of Privacy Act (the Act). A request to the Commissioner must be made in writing within 15 business days of the date of this letter or within a longer period that may be allowed by the Commissioner.
