Re: Your request for access to information under Part II of the Access to Information and Protection of Privacy Act [Our File #: SNL-076-2018]

On September 28, 2018, Service NL received your request for access to the following records/information:

“Would like to know how much money was paid to Service NL, broken down by payment, and what that payment was for, over the last 7 years. Would also like to know what moneys, if any, were paid to “Two Guys Training” over the last 7 years. Would also like to know, what payments were received from Safety Service NL / Newfoundland Safety Council, if any, for the use of the MRD training compound and storage shed for their training. Would also like to know if the shed was constructed using any outside funds.”

In emails sent on October 4, 9, and in the advisory letter on October 12, 2018 the following clarification was requested:

“Would you please review your submitted request to clarify exactly the information, specifically, when you say “money was paid to Service NL, broken down by payment, and what that payment was for over the last 7 years.” Do you mean all money paid to Service NL in this time frame? Or just money paid to “Two Guys Training”?”

On October 15, 2018, you clarified your request to the following:

“1) I would like to know how much money was paid to Service NL/Newfoundland Safety Council, broken down by payment, and including the payment amount, and what the payment was for, over the last 7 years.

2) I would like the same information, if there are any payments, to Two Guys Training, over the past 7 years.”

A subsequent email was sent on October 16, 2018 asking to clarify the two points:

“Do you mean all money paid to Service NL and Newfoundland Safety Council for the last seven years? Or just money paid to Service NL from the Newfoundland Safety Council for the last seven years?”

And to clarify your second point, do you mean money paid by Service NL to Two Guys Training over the last seven years?”

The clarification received from you on October 16, 2018 stated:

“1) I’d like a look at all government funds paid to Safety NL

2) money paid from Government to Two Guys Training (there may not be any)”

There were also several attempts to call you at the number you provided to speak with you. However, it was an automated service which would not allow the caller to contact a specific individual.

I am pleased to inform you that a decision has been made by Service NL to provide access to the requested information regarding payments made by Service NL to Safety NL. In accordance with your request, the appropriate copies have been enclosed. Please note this information is compiled and documented via financial management systems. The financial management systems list the company as Safety NL and CAPSC Safety Services Newfoundland. A search was conducted for both when compiling the requested information.

With respect to money paid to Two Guys Training, please be advised that Service NL has reviewed this part of your request and has no records responsive.

Service NL is only responsible for the records and information in its custody or control. Should you require information outside Service NL, you will have to contact the other department(s).

Please be advised that you may ask the Information and Privacy Commissioner to review the processing of your access request, as set out in section 42 of the *Access to Information and Protection of Privacy Act* (the Act). A request to the Commissioner must be made in writing within 15 business days of the date of this letter or within a longer period that may be allowed by the Commissioner.

You may also appeal directly to the Supreme Court Trial Division within 15 business days after you receive the decision of the public body, pursuant to section 52 of the Act.

Please be advised that responsive records will be published following a 72 hour period after the response is sent electronically to you or five business days in the case where records are mailed to you. It is the goal to have the responsive records posted to the Completed Access to Information Requests website within one business day following the applicable period of time. Please note that requests for personal information will not be posted online.
