On December 18, 2018 the Department of Tourism, Culture, Industry and Innovation received your request for access to the following records:

On December 19, 2018 the request was clarified and the wording updated to the following:

A request to the Commissioner must be made in writing within 15 business days of the date of this letter or within a longer period that may be allowed by the Commissioner.


