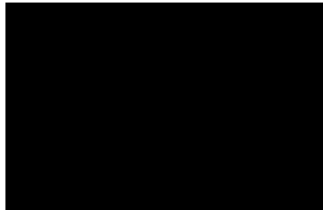

On April 15, 2019, the Department of Finance received your access to information request for the following:

“I am requesting a copy of all emails sent/received by the Minister of Finance's office from April 2018 to present regarding Memorial University and MUN.”

The Department of Finance has completed its search and is pleased to advise that your request has been granted and is attached.

Please be advised that you may ask the Information and Privacy Commissioner to review the processing of your access request, as set out in section 42 of the Access to Information and Protection of Privacy Act (the Act).

A request to the Commissioner must be made in writing within 15 business days of the date of this letter or within a longer period that may be allowed by the Commissioner. The address and contact information of the Information and Privacy Commissioner is as follows:

You may also appeal directly to the Supreme Court Trial Division within 15 business days after you receive the decision of the public body, pursuant to section 52 of the Act.

Please be advised that responsive records will be published following a 72-hour period after the response is sent electronically to you or five business days in the case where records are mailed to you. It is the goal to have the responsive records posted to the Completed Access to Information Requests website within one business day following the applicable period of time. Please note that requests for personal information will not be posted online.

### **Reinstatement of the needs-based grants program**

In the last five years funding to grants and subsidies has been cut by over 35 million dollars. Newfoundland and Labrador was once a model for accessible education with the full needs-based grants program, which allowed more students from vulnerable economic positions to attend post-secondary institutions without high-interest loans.

### **Increased funding to the College of the North Atlantic and Memorial University**

Over the past several budgets there have been successive cuts to the Department of Advanced Education, Skills and Labour. These funding cuts have resulted in an overall reduction in the quality of education that is being offered at both institutions with program closures, job loss, reduced supports, and increased fees.

### **Progressively reduce education fees to the point of elimination**
